

SUBJECT: Highlights for the Week Ending July 6, 2012

Legislature Passes Extension for Water Bond Ballot Measure— By votes of 72-7 and 34-2, respectively, the California State Assembly and Senate approved Assembly Bill 1422 (Perea) on July 5th, postponing the precarious \$11.14 billion water bond until the 2014 general election. Originally titled the *Safe, Clean, and Reliable Drinking Water Supply Act of 2012*, AB 1422, by Assembly Member Henry Perea (D-Fresno), which was designed to finance a safe drinking water and water supply reliability program, now authorizes the issuance of bonds in the amount of \$11,140,000,000 pursuant to the State General Obligation Bond Law, upon approval by the voters on November 4, 2014, statewide general election.

Earlier during the committee consideration of the bill, the Senate Natural Resources & Water Committee rejected a motion by Sen. Lois Wolk (D-Davis) to repeal the bond measure entirely. She cited a long list of issues with the bond in its current form on the floor, saying it should be repealed entirely. But she also said she decided to support the move because keeping it on this year's ballot would be "disastrous" for Gov. Jerry Brown's tax measure, which will also be up for in November.

The bond measure, which was originally crafted in 2009, was expected to face long odds on the ballot this year. Critics -- and even some legislators who voted for the bond -- say it is too large and contains too many appropriations not directly related to water infrastructure development and conversation. But even members who spoke against the bill in the Senate voted to move the bond to 2014. The Legislature originally approved legislation placing the bond measure on the November 2010 ballot as part of the 2009 water package. Lawmakers voted in August 2010 to move the bond to the November 2012 ballot, citing the state's economic woes and the need to focus on budget issues this year.





Senate President Pro Tem Darrell Steinberg said while the bond itself is being delayed, work on a deal to trim the size of the current bond should happen sooner rather than later. "If we're really serious about passing a bond measure in 2014, which I fully support, if we're serious about it, get to work now," Steinberg said. "With human nature, inertia and politics being what they are now, this is merely a band aid and we need the water investment, that's the key. We need to pass a bond. Let's get to it."

Item 9 – Res W-4924; Erskine Creek Water Company, Inc.'s General Rate Increase to Produce Additional Annual Revenue for Test Years 2012 and 2013. Advice Letter 80-W filed on February 8, 2012 - Related matters. Proposed outcome: Erskine Creek to file a supplemental advice letter with revised rate schedules; adopts the quantities used to develop the recommendations; and Erskine Creek to file a Tier 2 advice letter by November 20, 2012 and for Escalation Year 2013 with the rates being effective on January 1, 2013. Item 12 – Res W-4925; California American Water Company to Implement a Surcharge to Recover a Portion of the Balance in the Water Contamination Litigation Memorandum Account. Proposed outcome:

- Approves the tariff sheets filed with Advice Letter 905 and attached to this Resolution.
- Authorizes California American Water Company (CAW) to transfer \$1,146,053.61 from its Water Contamination Litigation Memo Account to a balancing account for recovery over a period of twelve months.
- Authorizes CAW to earn interest on the balance in this balancing account, at the 90-day commercial paper rate, from the effective date of this Resolution.
- Orders CAW to provide evidence of insurance against lawsuits including contamination lawsuits, documentation from its insurance company of the amount of all proceeds to offset these litigation costs, and documentation that Cal Am only booked costs in the account associated with water contamination lawsuits filed against the utility when it files for recovery of future balances in the Water Contamination Litigation Memorandum Account.

Estimated cost: \$1,146,053.61.

Item 37 – A10-11-009; Southern California Edison Company's Catalina Water Company Seeks to Increase Rates by 80%. Application of Southern California Edison Company for Authority to, Among Other Things, Increase Its Authorized Revenues for Santa Catalina Island Water Operations, and to Reflect that Increase in Rates. Proposed outcome:

- Disallows approximately \$1 million of operating expenses; approximately \$8 million in rate base; and by adopting Southern California Edison Company's alternate rate proposal, shifts \$10.7 million of the water company's increased costs as a one-time cost to electric rates.
- The result of our disallowances and adjustments makes no change in the current revenue requirement of \$3.948 million.
- Closes the proceeding.
